ISO 31000, Risk Management - Guidelines, is an international standard that provides principles, a framework and a process for risk management that help organizations take a proactive approach to the risks they face. It aims to help organizations of all types and sizes to manage risk effectively by integrating the risk management process into the organization's corporate governance, planning and strategy, management, reporting processes, policies, values and culture.

ISO 31000 aims to simplify the task of managing complex situations that require crucial decisions to be made through a structured approach to risk identification and assessment.

The Risk Management process involves following five steps that identify the circumstances, detect the exposures associated with the risk, assess and determine the risk, control the assessed risks and review the impact of the risks.

In addition to addressing continuity, the ISO 31000 standard provides a level of assurance in terms of economic resilience, reputation, quality, and environmental and safety performance.
