FDA INSPECTION: BEFORE, DURING, AND AFTER

Ariel Cruz - Retired FDA Consumer Safety Officer

This session will provide a comprehensive perspective on preparing for and managing FDA Good Manufacturing Practices (CGMP) inspections, drawing from a former investigator with the Food and Drug Administration, including best practices in preparing for an inspection based on CGMP standards, expected conduct during the inspection, including recommended behaviors and key insights on what to anticipate from the investigator and essential post-inspection activities to support compliance and continuous improvement. - Offer insights into effective engagement and best practices during an inspection.
- Provide guidance on closing an inspection, with an emphasis on responding to observations and identifying lessons learned for ongoing improvement.
